


Corridor capacity offer KPIs








Punctuality at origin (RFC entry)

ICM PaPs priority pilot

- Trains running on PaPs allocated by RFC5 have a priority in rerouting in case of ICM
- The scope is PLK, SZCZ, ZSR
- Started in TT2022, 1 year validity, possibility of extension tbd
- GT&C published with CID 2022 Annex G

Notes: Ratio of fulfilment for CIP is calculated taking into account:

- all visible principal lines and connecting lines A;
- the length (based on detailed geometries) of each CIP segment;
- length of CNC is 4472Km, of CIP lines is 4381Km
